### 1. Introduction

The Board of Directors of the Automotive Recyclers Environmental Association respectfully submit this report and its attachments (in electronic format only) to meet the requirements of Section 5 of the Vehicle Dismantling and Steel Recycling Environmental Planning Regulation.

The report summarizes the Association's Environmental Program as well as the Environmental Performance of its members over the past two years.

Finally, the report summarizes the level-playing-field issues that effect the Association's members.

# 2. Automotive Recyclers Environmental Association

#### 2.1 Purpose

The Automotive Recyclers Environmental Association (AREA) was formed in the fall of 1997. AREA is a non-profit association and its mission is to implement an Environmental Program for the automotive dismantlers and recyclers by:

- developing and administering the environmental management plan to ensure the environmentally safe removal, transportation, reuse or recycling of hazardous materials as required by the Ministry of Environment (MoE);
- overseeing the communication of information and the on-going training of the industry;
- working in partnership with the MoE, Environment Canada, the Insurance Corporation of BC and other partners to develop, implement and administer the environmental management plan in an effective and efficient manner.

# 2.2 Membership

As of September 1, 2018, there are approximately 180 automotive recyclers enrolled in AREA's Environmental Program. #### 2.4 Qualified Professional

Colin J. P. McKean has been designated as the Qualified Professional for the Automotive Recyclers Environmental Association.

Colin has a Masters of Science degree from the University of Victoria, is a freshwater biologist by trade and is a Member in Good Standing with the Association of Professional Biologists of British Columbia and the College of Applied Biology.

During his 33 year career, Colin has worked exclusively in the field of environmental management and specializes in the development and implementation of Environmental Management Systems such as ISO 14001, Environmental Stewardship Programs for industry and their products and Pollution Prevention Programs for industry and industrial sectors.

Colin has worked with the Ministry of Environment for 19 years and as an environmental management consultant for the past 14 years. At the end of his career with the Ministry of Environment, Colin managed the development and implementation of stewardship programs for household products including: pharmaceuticals, pesticides, fuels and solvents and industrial pollution prevention programs for large industrial sites. His work included preparing legislation and working with affected stakeholders to prepare appropriate stewardship and pollution prevention programs.

Now as a consultant, Colin is working with a number of industry sectors in the development and implementation of industry stewardship and pollution prevention programs. Currently, he has developed and

implemented the industry stewardship program for the Automotive Recyclers Environmental Association and the product stewardship programs for the Canadian Battery Association, the Tree-Marking-Paint Stewardship Association and a variety of pollution prevention and sustainability programs throughout the world.

# 2.5 Funding

All the funding for Automotive Recyclers Environmental Association comes from the membership. New members are charged a membership fee and all members pay \$525 plus travel expenses for an Environmental Review.

# 3. AREA's Environmental Program

AREA's approach to ensuring Environmental Performance and compliance to the recyclers Environmental Management Plan (EMP) has three important elements. The first element is the EMP that is updated on a regular basis and has

- an Environmental Code of Practice that summarizes in plain language the regulatory requirements for the management of hazardous materials;
- an Operational Contingency Plan in the event of an emergency; and,
- a site specific Environmental Management Plan that is signed by the Qualified Professional as well as the site owner or manager.

All three documents detail the removal, storage, transportation and disposal of the hazardous materials found in end-of-life vehicles under normal and emergency conditions.

The second element is the undertaking of an Environmental Review of the facility a minimum of once every two years by the Qualified Professional. The onsite Environmental Review is designed to determine the facility's compliance to the Environmental Management Plan as well as promote continual improvement towards the industry's Best Management Practices.

The third element is the development of a Pollution Prevention Plan that will outline the Corrective Actions identified during the Environmental Review. The Pollution Prevention Plan is signed by the Qualified Professional and the Owner/Manager.

### 3.1 Environmental Management Plan

Each registered facility will have a binder that contains the facility's Environmental Management Plan (EMP). The EMP will be signed by the Qualified Professional and describe how each of the following hazardous materials will be removed from wet vehicles at the facility and stored, treated, recycled or disposed of in compliance with the Act and applicable regulations.

The hazardous materials included in the EMP are:

- ozone depleting substances and other halocarbons;
- oils, brake fluids, solvents, fuels and other hydrocarbons;
- waste antifreeze;
- lead and lead-acid batteries;
- tires:
- mercury switches;
- windshield washer fluid

In addition, the facility will have an Emergency Management Plan that will provide the basic requirements during an emergency as well as a summary of the Best Management practices that will minimize or eliminate the discharge of wastes to the environment.

#### 3.2 Environmental Review

AREA developed the Environmental Review to ensure that inspection results are easy to understand, consistent and promotes best management practices designed to minimize or eliminate discharges of hazardous materials to the environment. A typical inspection should not take more than a couple of hours to complete and at the end of the Environmental Review, the owner / manager reviews and signs off on the results with the Qualified Professional.

In addition, the Environmental Review was designed to determine:

- how the wastes described in the Environmental Management Plan are managed by the facility,
- whether the management of those wastes was in accordance with the facilities Environmental Management Plan, and
- the effectiveness of the management processes used for minimizing or eliminating the discharge of wastes to the environment under normal and emergency conditions.

AREA's Environmental Review template that was used during the reporting period is attached in Appendix 2.

#### 3.3 Pollution Prevention Plan

In addition, the Environmental Review is quantified so that AREA Members can see how their facility compares to an industry average and Best Management Practices.

To facilitate the promotion of continual improvement, AREA ranks the Environmental Performance of each facility into three categories: Gold, Silver, Bronze. The Gold Level recyclers have demonstrated the highest compliance to their Environmental Management Plan and the Best Management Practices of the industry.

Facilities that do not achieve the Bronze rating will be required to undergo additional training at their own expense. Failure of the facility to achieve Bronze after the additional training will have their membership in AREA cancelled.

#### 4. Environmental Performance

#### 4.1 Members Performance

The individual Environmental Review results will be supplied to the Ministry of Environment in a separate Excel database (see attached file MOE Inspection Summary). In the interest of saving paper, the database has over 1100 pages of results and will remain in electronic format.

For reporting purposes, the individual result for each automotive recycler is summarized in the file "MOE Inspection Summary". The Ministry of Environment must recognize that the individual results listed in Appendix 1 and the attached file is considered "Private" and the individual results should not be released to the public. The Ministry is welcome to release the rankings of the recyclers if they so choose.

Because the score sheets used in the Environmental Review are quantified, the Environmental Performance of AREA members are rated using a simple rating system and the rating is available to the public and is published on the internet at <a href="http://www.area-bc.ca/index.php/membership">http://www.area-bc.ca/index.php/membership</a>.

The AREA rating system is:

Gold: Greater than 92%; Silver: Between 84 and 91% Bronze: Between 75 and 83% Below Standard: Less than 75%

During the reporting period (September 1, 2016 to August 31, 2018), AREA conducted 87 inspections of its members and had 5 members fail to reach the 75% standard set by the AREA Board of Directors.

As of September 1, 2018, the breakdown of AREA membership based on the rating system is as follows:

Gold: 109 Members; Silver: 38 Members; Bronze: 49 Members;

Below Standard: 2 Members

Facilities that do not achieve the Bronze rating will be required to undergo additional inspections at their own expense and their membership in AREA cancelled if environmental performance does not improve.

# 4.2 Level Playing Field - Non-Compliant Recyclers

Over the years, the Automotive Recycling Environmental Association membership has identified numerous businesses or individuals who are processing 'End of Life Vehicles' (ELV's) on both Provincial and Federal lands without regard for the potential negative environmental impact or without the proper regulatory certification.

The BC Ministry of Environment should contact AREA for the userid and password to review the non-compliant automotive recyclers.

Although no detailed inspections were conducted on the non-AREA companies, it was apparent that most of the companies were not in compliance with Federal or Provincial environmental regulations. The noted non-compliance issues included;

 Improper handling, storage and disposal of hazardous waste (oil, gasoline, antifreeze and batteries) that may contribute to soil, surface and/or groundwater contamination and introduction of air pollutants;

- Crushing End of Life vehicles without first removing all hazardous waste from the vehicles;
- Failing to register with the Ministry of Environment prior to crushing End of Life vehicles.

Regulatory agencies are encouraged to use the list of non-compliant recyclers and create a level-playing field for the compliant auto recyclers.

### 5. Conclusion

The majority of AREA members are in compliance with their Environmental Management Plan and the overall performance of the industry is good and continues to improve. Five AREA members did not achieve the minimum standard set by the AREA Board of Directors and were required to make improvements and undergo additional inspections.

As of August 31, 2018, only two AREA members were below the minimum standard.

AREA estimates that there are 55 automotive recycling facilities in British Columbia that are not registered with the Ministry of Environment and are likely not in compliance with Federal or Provincial regulations. AREA believes that these "fly-by-night" operations are creating a significant unlevel playing field and causing serious economic hardship to AREA members.
